

Marlborough Mobility Parking Permit Information





Note: Time limits apply to some car parks

The concessions available to you as a member of the Mobility Parking Scheme have been granted with the consent of the local authorities – not by right of law. Your co-operation is essential to ensure that these concessions are not abused.

- Membership is not transferable.
- The permit must only be used by the permit holder and can be used in any vehicle.
- Your permit must be clearly displayed on the dashboard or hanging from the rear vision mirror of the vehicle when parked.
- A Mobility Parking Permit allows parking in mobility car parks in private car parks – eg. hospitals, supermarkets etc. as well as council owned car parks

Concessions Marlborough Area

P10	Permit allows double time to 20 minutes
P15	Permit allows double time to 30 minutes
P30	Permit allows double time to 60 minutes
P60	Permit allows double time to 120 minutes
P120	NO FURTHER TIME EXTENSION

Payment Required Car Parks 'Pay by Plate'

Permits allow double the time paid for provided double the time does not exceed the car park time limits. For example:

Zone 1 – Kerbside park limit in Zone 1 is two hours. Permit holders can't park for longer than two hours even when parked in a disability space in Zone 1.

Zone 2 – Off-street park limit in Zone 2 is four hours. Permit holders can't park for longer than four hours even when parked in a disability space in Zone 2.

Even if parked in a Disability Parking space payment must be made.

No Concessions Apply to:

- Alfred Street car park building the current system being used does not allow for time concessions.
- Areas where there is Free Parking but a restriction on the time allowed.

Mobility Parking Permits DO NOT ALLOW

Stopping/Parking/Waiting on:

- Broken yellow lines
- Taxi Stands or Bus Stops
- Clearways
- Goods Loading Zones
- No Stopping Zones
- Double parking
- Anywhere else where stopping and/or parking is not permitted

Council-owned car parks are policed by Parking Wardens. Mobility Parks on private land (hospital, supermarkets, etc.) are the responsibility of the management/landowner of that site. Any complaints you may have should be directed to the landowner/management concerned.



Changes to Mobility Parking

CCS has been working with the Ministry of Transport to make changes to legislation so fine levels for the misuse of mobility parking spaces can be increased. As a result, a new amendment to the Road Transport Rules has been established and came into effect on 17 January 2008.

In summary, the new rule states that only vehicles where the driver or passenger is disabled, with an approved disabled person's parking permit, such as a CCS Disability Action Mobility Parking Permit, prominently displayed in the vehicle are able to use a mobility parking space.

Please note that this legislation change is to on-road public parking, and Council off street carparks only and does not include private parking providers.

With the new Rule, fines can now be increased for the misuse of a mobility park. On 26 June 2008, the fine for abuse of a mobility parking space was increased from \$40 to \$150.

Permit holders must make sure that their Mobility Parking Permit is valid and clearly visible when using mobility parking spaces.

FAILURE TO CLEARLY DISPLAY THE MOBILITY PARKING PERMIT WILL RESULT IN AN INFRINGEMENT NOTICE BEING ISSUED FOR \$150.00. PLEASE ENSURE THE MOBILITY PARKING PERMIT IS DISPLAYED AT ALL TIMES.
