Due on 1 July 2021

Category <i>Please note a proportional fee is charged for dogs registered for the first time part way through the year.</i>	Annual Fee
Responsible Dog Owner Each dog must be desexed, microchipped and have no infringement notice or conviction under the Dog Control Act 1996 for the last two years, i.e. since 1 July 2019.	\$60
Standard Dog Any non-working dog that does not meet all of the responsible dog owner criteria. This includes any dogs that have been classified as 'Menacing'.	\$90
Old Dog For dogs over 12 years old (as of 1 July 2021) that were registered for the first time prior to 1 July 2009 (proof of registration or age is required).	\$45
Dangerous Dog This includes any dogs that have been classified as 'Dangerous'. Dangerous dogs are excluded from the old dog and responsible dog owner categories.	\$135
Working Dog Includes farm dogs primarily used for herding stock.	\$20
10 + working dogs For each additional working dog.	\$10
Replacement tag If your current tag is lost, damaged or stolen.	\$5 per tag

A late penalty fee is charged (50% of the applicable fee) for payments made after 31 July 2021. The registration year runs from 1 July 2021 to 30 June 2022. All dogs over the age of 3 months must be registered.

What your registration fee pays for

Your dog registration fees help to fund a range of services to help dogs, their owners and the community, such as:

- Monitoring and enforcing the Dog Control Act 1996 and ensuring compliance with the Marlborough District Council Dog Control Policy and Bylaw.
- Responding to and investigating complaints (including dog rushes, attacks on people, pets and stock, barking nuisance, roaming and lost and found dogs).
- Providing and maintaining pound facilities and the Renwick Dog Park.
- Patrolling public areas, reserves, parks, beaches and sports fields throughout Marlborough.
- Providing education programmes, and signage to promote community safety.

There are additional costs associated with vehicles, facilities, administration, record keeping (including the updating of the National Dog Database) and staff costs.

There is also a small ratepayer contribution towards the cost of animal management services for stock control on roads.

Microchipping

All dogs registered in New Zealand for the first time after 1 July 2006 (with the exception of working farm dogs) must be microchipped. The microchip certification or verification needs to be provided to Animal Control. Puppies must be microchipped within 2 months of their first registration.

Microchipping is a simple and safe way to identify dogs and your dog is more likely to be returned to you if it is lost or stolen (Animal Control provides this service for \$25).

Being a responsible dog owner

Dogs must be controlled at all times and wearing the correct **RED** dog registration tag when out in public.

Please fence your property so that any visitors have safe access to your front door without coming into contact with your dog.

If you have more than two dogs on a property you need to have a multiple dog licence (with the exception of rural zoned properties).

You must remove faeces immediately when your dog defecates in a public place and dispose of this appropriately.

Collars, leads, muzzles, bark collars and worm tablets are available for purchase from Animal Control / Maataa Waka.

Obligations of dog owners

Section 5 of the Dog Control Act 1996

- To ensure that the dog is registered as required by law, and notify Animal Control of any change of address or ownership.
- To keep the dog under control at all times.
- To supply the dog with proper care and attention and with sufficient food, water and shelter.
- To ensure that the dog has adequate and regular exercise.
- To ensure that the dog does not cause a nuisance to any other person, whether by persistent or loud barking or howling, or by any other means.
- To take all reasonable steps to ensure that the dog does not injure, endanger or cause distress to any person.
- To ensure that the dog does not injure, endanger or cause distress to any stock, poultry, domestic animal or protected wildlife.
- To take all reasonable steps to ensure that the dog does not damage or endanger any property belonging to any person.
- To comply with the requirements of the Dog Control Act 1996 and the Marlborough District Council Dog Control Policy and Bylaw.

Please report any incident to Animal Control where you, your pet or stock have been intimidated or attacked by a dog. It may happen again and be more serious.
