Total Control Pest Progress Summary




Figure 1: Total Control plants destoyed by year

Total Control pest work has been completed for the 2016/2017 financial year and the number of plants controlled has reduced significantly compared to the previous year (Figure 1). This has been attributed to the lower numbers of Bathurst Bur, Saffron Thistle, Bone Seed and Moth Plant destroyed in 2016/2017 compared to the numbers controlled in 2015/2016.

Parrots Feather (E315-003-015)

Biosecurity staff have been working on controlling a large infestation of parrots feather in the Ōpaoa Loop in the vicinity of Roses Overflow. The initial infestation was found in late 2016 and herbicide applications were made to control the emergent biomass of the plant (Figure 3).

After the initial herbicide applications, biodegradable mats were applied to the substrate to block out sunlight to prevent any regrowth from the plant's root system. This method has been used successfully to control parrots feather infestations in Ruakanaka Creek (Figure 4).

The site of the infestation will be kept under "surveillance" so followup work can be undertaken if required.

Chilean Needle Grass (E315-004-003-01#02)

Successful Bid to the Ministry for Primary Industries

The Chilean Needle Grass Action Group, along with the Landcare Trust and the Marlborough District Council, have been successful in a bid for funds to research tools for effective management and control of Chilean Needle Grass and other biosecurity risks. The bid was part of an overall package aimed at earthquake affected areas. The project will build on the adaptive management approach developed by landowners and the Council to improve control techniques and land improvement. The project also has inputs from other partners, including the Marlborough Research Centre, ECAN, Hawkes Bay Regional Council, Beef and Lamb NZ, Wine NZ and Landowner contributions. The proposed budget for the project, including Ministry for Primary Industries funds, in kind support and contributions is likely to be in excess of \$500K.

Marine Biosecurity (E315-013-002)

Top of the South Marine Biosecurity Partnership

The Top of the South Marine Biosecurity Partnership contract for 2017/18 has been agreed and signed with Lawless Edge Limited. The partnership, which includes the Ministry for Primary Industries, Tasman District Council, Nelson City Council and Marlborough District Council, has recently been recognised nationally at the NZ Biosecurity Awards held at Parliament. Marlborough District Council is managing the contract this year on behalf of the partnership group. The contract has three main deliverables;

- Regional Coordination, including organising and managing the Top of the South Marine Biosecurity Partnership meetings and developing links with other regions
- Communications, maintain and manage the website and newsletters http://www.marinebiosecurity.co.nz/
- Projects, including science advice, summer survey of mobile and moored vessels, training operators, initial incident response and policy advice.

Environmental Science

Nitrate Loss Under Vineyard Soils on the Wairau Plains (E355-004-009-01)

A set of drainage flux meters (DFMs) have been installed at Giffords Road on the Northern Wairau Plain. These devices can measure both the rate of water loss (ie; drainage) and the rate of nutrient loss (ie; leaching) from the vineyard. Nitrate loss is very low (3-4 kg/ha/yr) compared with other land uses. Ongoing monitoring is needed for different climatic conditions. We currently have five years of data. Trials have been successful at determining nitrate losses and provide a baseline (for viticulture) which exists on most of the Plains. Continuation of the trials has been important to cover more diverse range of rainfalls.

The results of the trials can be used in conjunction with hydrogeological information, soil and land use information to model the impact on water quality of the aquifer and springs. A simple water balance model to estimate changes in soil water content and drainage losses from the vineyard is being developed by Plant and Food Research. This data will be useful in estimating recharge rates and testing models of the land surface and groundwater interactions.

Caseys Creek - Water Quality Baseline Study (E375-008-001-01)

Background

A number of properties along the eastern fringes of Blenheim are being developed for residential housing. Residential development results in an increase in hard surfaces, which do not allow rainwater to penetrate into the ground. The excess rainwater is collected in stormwater systems and usually discharged into a nearby stream or river. Stormwater contains a number of contaminants that are washed off roofs and roads, most notably heavy metals, such as Zinc from roofing iron and vehicle brakes. Other contaminants are hydrocarbons, such as oils. High concentrations of sediment are usually a problem during initial development and the building phase.

One of the areas developed for housing is the De Luxe property, located to the northwest of Blenheim. Stormwater from this development will be discharged into Caseys Creek.




Figure 5 - Location of the planned residential (De Luxe) development and Caseys Creek

Caseys Creek is a relatively short, spring-fed stream. The creek's channel is highly modified, but due to the significant inflow of clear, cool groundwater, it has favourable water quality. It is anticipated that the development of the De Luxe property will impact the water quality of the creek.

It was therefore decided to gain a good understanding of the water quality before the development takes place. We were asked by the Assets & Services Department to carry out the work, which consisted of several water quality sampling runs, stream sediment sampling and an ecological assessment, including a fish survey. A report summarising the results was completed in July 2017 and will be included in the resource consent application for the development. This report is available to view in Trim (reference 17152694).

Result Summary




Figure 6 - Top: Map of the sampling sites (with site numbers) on Caseys Creek. Bottom: Results for E. coli, Turbidity and Dissolved Cooper concentrations. The different sampling conditions are distinguished by colour. Sample results for E. coli marked orange indicate samples analysed for genetic markers.

The water quality sampling was carried out during dry weather, light rain and heavy rainfall. Unsurprisingly the results showed that water quality was most impacted during heavy rainfall (see Figure 6).

The monitoring also revealed that during rainfall, the highest contaminant concentrations were almost always observed in the upper reaches of Caseys Creek, where rural land uses are the main influence. This included concentrations of the heavy metals Copper and Zinc, usually associated with urban influences.

A number of E. coli samples were analysed for genetic markers in order to identify the sources of faecal contamination. All samples contained faecal matter from ruminant sources and, for most samples, wildfowl and dogs were also sources of faecal contamination. Human bacteriods, an indicator for sewage contamination, were present at the two most downstream sites.

In the sediment from Caseys Creek all heavy metals were found in concentrations above the detection limits. However, the only heavy metal above guideline level was Nickel, which at all sites was found in concentrations at or slightly above the ISQG-Low guideline. This guideline indicates the potential onset of possible biological effects. Polycyclic Aromatic Hydrocarbons (PAH) in the sediment were well below the ISQG-Low levels for the individual analyses and the guideline level for Total PAHs.

The fish survey revealed that Caseys Creek is home to a number of native fish species, including Longfin Eel, Inanga and Giant Kokopu. The find of a Giant Kokopu was of particular interest, as these fish are rare on the Wairau Plain (only eight other observations since 1974) and nationally at risk of extinction.

Water Resource and Climate Update and Summary to 31 July 2017 (E320-001-001)

This report is prepared using data from Council's environmental monitoring network, as well as sites operated by NIWA and data from the Marlborough Research Centre.


Executive Summary

In contrast to June, which was dry across the district, July rainfall was average to above average in all areas. For other climate parameters, July was a fairly average month.


Rainfall

Coastal and southern Marlborough rainfall was very close to average, while high country and Marlborough Sounds areas exposed to northwest rain events received above average rainfall. Generally rainfall totals this year are tracking about average to slightly above average.

The following graphs show the monthly rainfall totals for 2016-17 at four representative sites, compared to the long-term monthly averages for those sites. The Blenheim graph also shows the actual monthly evapotranspiration (ET). The difference between monthly rain and ET indicates the likely soil moisture gain or loss.




Tunakino Rainfall (representative of Pelorus/Rai Valley area) Year to date 1411 mm, which is 105% of YTD long term average.




Branch Rainfall

The Harbour Maritime Safety Management System Maritime sets out Performance Monitoring and Reporting requirements. By reporting regularly on key indicators, reflecting both the performance of the Harbour Authority and that of port and harbour users, appropriate measures can be adopted and introduced which may further improve maritime safety.

A consultation phase for the proposed Navigation Safety Bylaws commenced in early August and will run through to 31 October. Feedback around jet-ski registration and lifejackets has generally been supportive so far.

The Navigation Safety Bylaws will primarily target recreational vessels. Regulation of large ships will be achieved under the Maritime Transport Act via Harbour Master Direction.

Work has begun on formulating the General Direction mentioned above. This will be a core document regulating commercial maritime activity in the Harbour including shipping, pilotage and towing.

The Harbours office has received \$45,000 funding from Maritime New Zealand to run recreational boating safety campaigns. \$20,000 has been allocated for continuation of the Skippers Workshops and \$25,000 for a safe speed enforcement campaign. The latter is to be designed as a pilot programme for all of New Zealand.

A draft 2017 Marlborough Harbour Risk Assessment was received on 11 August. This work by Marico Marine and informs the Harbour Safety Management System. The Harbourmaster is presently reviewing the draft document.

A project has begun to tie all of the Harbour activities back to risk. There is a need to show a clear link between the maritime risk identified in the Harbour Risk Assessment and how mitigation of each of these risks relates to the work the Harbours team undertakes. The intention is to be able to demonstrate the real cost of mitigating each risk.

The Transport Investigation Commissions investigation into the grounding of the Cruise Ship Azamara Quest continues with final recommendations expected later this year. Work continues with Port Marlborough to embed the lessons learned from this incident and ensure a safe efficient pilotage service and provision of a safe waterway.

A revised draft MDC pilot exemption certification programme has been circulated for comment from key stakeholders. This certification programme is the means by which a Cook Strait ferry master and other ships masters are able to operate in the waters of the region without a pilot on-board.

The Harbour Masters skipper training workshops continue to prove popular. To date over 180 people have attended the course. Thanks to MNZ funding Coastguard Boating Education (CBE) is providing administration support to ease the burden on Harbours staff of running these courses.

The Harbour Masters skipper training workshops have also led to a positive uplift in enrolments in the CBE Day Skipper course. In June sufficient enrolments in the Day Skipper course enabled it to be run in Marlborough for the first time in more than three years. A second Day Skipper Course is to be run in Picton on 19 - 20 August.

Work continues on evolving the Cruiseguide to better meet the needs of boaties. Educational videos are being developed to explain how to use water-ski lanes, navigate near ferries, utilised VHF radio in Tory Channel/Kura Te Au and other key messages.

A target of auditing 200 marine farms during the financial year has once again been set. The focus this year will be on ensuring follow up audits are undertaken. Discussions have commenced with the MFA to see how we can better align with their own audit regime to enable better efficiencies.

All navigation aids and lighthouses have been maintained to the standards and specifications required by the International Association of Lighthouse Authorities.

Mass Rescue and the preparedness of Marlborough to cope in such an event have sparked a revisit of the draft MRO plan with the Harbour Master, Police and Civil Defence. It is expected that a finalised response plan will soon be put in place with public engagement and exercises to follow.

Twenty incidents have been recorded since the last incident. One of the noted oil spills had potential to be much larger and occurred on a vessel that has had two additional spills since October. The Harbour Masters team has worked with the vessel and fuel supplier to ensure sufficient systems procedures and infrastructure are in place.



TA Functions:

Swimming pool inspections: At the end of June, 255 site inspections have been undertaken with the majority of pools inspected complying.

Earthquake Prone Building Amendment Act 2016: The methodology and regulations for this new act were released by MBIE in July. Bill East, Tony Adamson and Kaye McIlveney will be attending a training event in Nelson to work through the implications.

Main points:

- There are three main categories of buildings:
 - A = Unreinforced masonry buildings.
 - B = Pre 1976 buildings (3 or more stories or 12 metres or greater height above the lowest ground level).
 - C = Pre-1935 buildings that are 1 or 2 stories.
- Creation of "Priority Buildings" from any of the above categories.
- The act deals with parts of buildings.

Timeframe from 1 July 2017 for identifying possible buildings:

- Priority Buildings: The TA must identify possible buildings within a 2½ year period.
- All Other Buildings: The TA must identify possible buildings within a 5 year period.

Timeframe from 1 January 2020 for the owner to remediate the building:

• Priority Buildings: The owner must remediate within 7.5 years.

Timeframe from 1 July 2022 for the owner to remediate the building:

• All Other Buildings: The owner must remediate within 15 years.

The timeframes are variable dependant on:

- The owner's ability to source engineers to complete their investigation (an additional 12 months extension to timeframe can be approved).
- Whether the building is historic (an additional 10 years extension to timeframe can be approved).



Resource Consents Section



Over the first 30 weeks of the 2017 calendar year, the Council received 574 applications for resource consent. Of that total, 535 were new applications for resource consent. The Council also received 33 applications under section 127 (variations to resource consent conditions), four extension to lapse dates under section 125 and two objections to conditions under section 357. Over the same period in 2015 and 2016, the Council received 720 and 785 applications respectively. The average number of applications received weekly to date in 2017 is 19.1.

Number of applications received for Resource Consent



Over the first 30 weeks of the 2017 calendar year, the Council issued 542 applications. Of that total, 502 were applications for resource consent. The Council also issued 36 section 127 decisions (variations to resource consent conditions), three extension to lapse date under section 125 and one objection to conditions under section 357.



Number of Resource Consent applications issued

Since the final part of the Resource Management Amendment Act 2013 came into effect on 3 March 2015 the Council has rejected 241 applications for resource consent for incompleteness. Prior to this legislative change the Council rejected less than 1% of all applications received. Over the first 30 weeks of the 2017 calendar year, the Council has rejected 27 applications (4.7%). There has been a significant reduction in the number of applications that are being rejected which indicates a better understanding by applicants of the new requirements.

There are currently 483 applications being processed by the Resource Consent Team. In 2015 the number in processing was 260 and in 2016 the number in processing was 331. The number of applications spiked with notification of the new Plan on 9 June 2016. However, since the earthquake on 14 November 2016, the number of applications has gone down.

Despite a reduction in the number of applications, Duty Planner enquiries are continuing at a high volume. In order to try and provide a Duty Planner service that better meets the needs of the public the Resource Consents Section has adopted a new process. All phone and counter enquiries now go through a Customer Service Officer first. The initial step involves those making an enquiry to provide contact details and sufficient information to enable the Duty Planner to research the enquiry and provide a response. The Duty Planner enquiry record sheets are logged in order of receipt into the DP inbox. Ordinarily enquiries are dealt with in the order received. The Duty Planner has the ability to triage significant or urgent enquiries and deal with them appropriately. The Duty Planner now provides email responses to all enquiries. If the client does not have email the Duty Planner will phone them with a response. The Duty Planner is also available for two hours a day for appointments. The Customer Service Officers now make the appointments which are limited to 30 minutes. The Council does not charge clients for the first 30 minutes of Duty Planner time. The new process is enabling the Duty Planner to provide a better quality response.

Unfortunately the volume of work is still overwhelming for one officer. Consequently the Council is currently advertising for a second Duty Planner.

The Resource Consent Team lost over fifty years of resource management experience last month with Guy Boddington retiring and Alan Anderson leaving to work at a local consultancy. Guy has trained Ryan McAlister to take over the forestry and rural land disturbance applications. Alan has trained Emma Deason to take on some of the discharge applications. The Council has appointed a new intermediate level resource management officer with experience in regional planning. Victoria Bell will be starting at the end of the month. She will be mentored by Glen Parker.

The second phase of Government's reform of the Resource Management Act 1991, the Resource Legislation Amendment Act 2017 (RLAA), obtained Royal Assent on 18 April 2017. It contains approximately 40 amendments and makes significant changes to five different acts, consequently amending several others. This is the most comprehensive package of reforms to the Resource Management Act 1991 since its inception 26 years ago.

The intent of these changes is to deliver substantive improvements to the resource management system, to support more effective environmental management and drive capacity for development and economic growth. In particular, the amendments aim to provide stronger national direction, a more responsive planning process, a streamlined resource consent process and better alignment with other legislation.

The RLAA directly amends five different acts: the Resource Management Act 1991, Conservation Act 1986, Reserves Act 1977, Public Works Act 1981 and Exclusive Economic Zone and Continental Shelf (Environmental Effects) Act 2013. Consequential changes have also been made to other acts.

Some of the changes to the Resource Management Act 1991 have taken immediate effect. Other changes have transitional periods specified in the RLAA. The majority of changes to the resource consent process come into force six months after enactment, on 18 October 2017.

The Ministry for the Environment has provided a checklist which sets out the actions that councils need to take to implement these changes immediately and over time. The Ministry has also provided 16 fact sheets with information about the changes to the Resource Management Act 1991 and other acts, including specific timeframes that apply. Fact sheets available on the following:

- 1. <u>New options for national direction</u>
- 2. <u>Revised functions for RMA decision makers</u>
- 3. Changes to Maori participation in the RMA
- 4. Changes to the standard planning track
- 5. <u>A new optional streamlined planning process</u>
- 6. <u>A new optional collaborative planning process</u>
- 7. Changes to heritage protection under the RMA
- 8. <u>New consent exemption and fast-track processes</u>
- 9. Changes to resource consent notification
- 10. New matters to consider for resource consents and designations
- 11. Fixed charges must be published, and regulations may set fixed charge requirements

- 12. Alignment of Conservation Act and Reserves Act processes with the RMA
- 13. Changes to public notices, electronic servicing and submission strike out
- 14. Changes to objections and Environment Court processes
- 15. Changes to the board of inquiry process
- 16. Changes to land acquisition under the Public Works Act

The guidance material is on the Ministry for the Environment website. At this stage the Ministry is developing and drafting technical guidance for the consenting changes in the RLAA. The Ministry has hosted a regional workshop on the National Planning Standards and the RLAA for planning managers from the three Top of the South councils. Local Government New Zealand live streamed a webinar designed for elected officials and independent commissioners on the RLAA. It is expected that there will be further workshops and webinars prior to the consenting changes coming into force.

The Resource Consents Section has been extremely busy with hearings over the last couple of months. A number of these hearings have been very controversial. There are four hearings scheduled for the next two months:
