Refund Entitlements

Category 1 requirements are:

- Dog is neutered – Verification from your vet must be provided with this form,
- Microchipped – Verification from your vet must be provided with this form,
- A dog is not classified as dangerous or menacing,
- The dog owner has not been classified as probationary or been disqualified,
- The dog owner has not been convicted of an offence under the Dog Control Act 1996 in the past seven years, and
- A dog whose owner has not committed any infringement offences under the Dog Control Act 1996 in the previous 2 registration years.

A category change rebate will only be issued to owners of dogs who meet all of the above criteria.

The part fee refundable is calculated on the basis of the number of complete months remaining in the registration year after the date of request for the refund.
