Proposed Marlborough Environment Plan Hearing Notice - Block 13, Woodlot Forestry - Supplementary

The hearing for the Proposed Marlborough Environment Plan (PMEP) recommences on 29 April 2019 with Block 13, Topic 22: Woodlot Forestry – Supplementary.

The topic of Woodlot Forestry was heard prior to the Council completing an alignment of the PMEP with the National Environmental Standard for Plantation Forestry (NESPF). The NESPF alignment process does not affect or apply to the Woodlot Forestry provisions of the PMEP. However, many of the rules/standards for woodlot forestry are the same as those that apply to commercial forestry. At the Woodlot Forestry hearing, the Section 42A report writer signalled the potential need to revisit the topic to consider consistency between these provisions post alignment. The Panel considers this to be warranted and wishes to recommence the hearing of the woodlot topic.

A supplementary Section 42A Report has been prepared. It is confined in scope to issues of consistency with commercial forestry provisions post NESPF alignment.

Note: The hearing on these topics is limited to content covered by the submission points listed in the hearing notice. If you need clarification on which of your submission points this relates to, please contact us.

Venue

The hearing will be held in the Council Chambers, Marlborough District Council Administration Offices, Seymour Square, Blenheim.

You may also wish to give evidence by providing a written statement or discussing additional information, including expert evidence, which was not provided with your original submission, but which is relevant to and supports issues raised in that submission, or call a witness to do this on your behalf. If this is the case, all written material can either be provided by **5:00pm**, **26 April 2019** for distribution to the Panel. Alternatively, you may provide evidence and/or legal submissions on the day. If this is the case, please ensure you bring at least nine copies.

We prefer that you provide any evidence electronically. You can do this by emailing Louise Walker at MEP@marlborough.govt.nz. Please note that there is a 20MB limit on emails.

If you are unable to provide your evidence electronically, or your document is going to exceed the size limit, please contact Louise Walker.
