MINUTE OF THE ENVIRONMENT COURT (21 December 2020)

Introduction

[1] This Minute makes further case management directions in relation to mediation for the appeal proceedings concerning the proposed Marlborough Environment Plan ('pMEP').

Mediation

[2] The MDC have now filed an amended mediation schedule (after addressing further matters raised by parties) for Group 1 for the court's approval. Beyond Group 1 MDC has been unable to estimate dates for mediation, so these will be confirmed at a later date. The court has now allocated Commissioner resources to facilitate the mediation schedule and can generally work with the dates proposed,¹ subject to the following guidelines:



With one exception being five days allocated to the week of 8 June 2021 which includes a public holiday. Four days will be scheduled at this stage and if a full week is required the court can allocate it to the previous week.

- (a) if for any reason the parties wish to request a change to the schedule for a specific topic they must first obtain agreement from all other parties to that topic before advising the court accordingly. No change to the timetable will be considered without such supporting documentation and even then, the court for resource reasons may not be able to accommodate a change;
- (b) the MDC will circulate an A3 table ten working days prior to mediation setting out the appeal details and relief sought for each topic and subtopic by party, together with a summary of MDC's preliminary position;
- (c) having reviewed the MDC's preceding materials, the parties are to circulate indicative position papers in response up to **five working days** prior to mediation which should describe their issues with provisions under discussion and their suggestions for how their concerns could be met at mediation in a 'without prejudice and confidential' way;
- (d) the MDC will provide its position paper in word format, and the parties may elect to use the MDC's table as a base for their own position papers by adding a column;
- (e) the MDC's position paper in most instances will form the agenda for the mediation. Unless otherwise agreed, individual points of relief will be mediated (and any relevant matters will be addressed) in the order set out in the MDC's position paper.

Service

[3] MDC has also filed a memorandum in response to the court's 29 October 2020 Minute addressing the directions it seeks in relation to the service of documents. I consider the revised service proposal is appropriate so I will make the directions sought.

Directions

- [4] It is <u>directed</u>:
 - (a) the mediation schedule attached is approved (and parties are to file position papers in accordance with paras [2](a)-(e) above);
 - (b) a party has sufficiently complied with its obligations of service if it files and serves the document electronically with the court and to the relevant parties;



- (c) if a party has a very large document, they may provide it to MDC before service. MDC must upload it to the portal and provide a URL link for the document which the party will then serve;
- (d) MDC will upload all documents filed and served in accordance with paragraph (b) to the appeals portal.
- [5] Leave is reserved for any party to apply for further (or other) directions.
