#### **Purpose of report**

1. To provide Councillors with a summary of the consultation process.

#### RECOMMENDATION

That Council agrees to confirm the decisions it made as part of the February 2022 Budget Meeting regarding increased levels of service.

#### Comments

- 2. This year's consultation process yielded 75 submissions. This number is slightly down on previous years and most likely reflects that the direction taken by Council over recent years and suggested increased levels of service. This is reinforced by the responses to the questions posed in the Consultation Document where by far the biggest number of responses were "NA", followed by "yes", with the biggest number of "no" answers to any question being 2 (see Appendix 4.1).
- 3. Also as has been the case in the past, submissions have been made on a very wide range of topics. While many of the issues raised do not have budgetary impacts, the submission process is a very important way for the community to engage with Council.

#### **Submissions**

- 4. The **attached** (as **Appendix 4.2**) identifies the topic areas contained in submissions and how frequently the topic is raised.
- 5. As can be seen from Appendix 4.2, the biggest number of submission responses related to "Other" 28, followed by "Community Facilities" 15, and Community 11. All other activities generated 6 or less responses.
