1. Picton Water Supply – Stuart Donaldson MDC

Stuart gave a presentation attached as Appendix 1.

- The water assessor who checks water standards is independent of Council and works for the DHB.
- A new regulator is being established who will rewrite the standards. This is expected to take a while to get into place.
- Leak detection is carried out every 2 to 3 years.
- In Picton last year there were 178 commercial water meters. They used 13% of the total use. The Port is the largest commercial user of water.
- Water meters have been budgeted in the 2022/2023 Long Term Plan. There will be consultation with the community. It is expected there will be 12% savings in water with the installation of metres.
- Use of reclaimed water has been budgeted for in the Long Term Plan. Reclaimed water can be used for non-potable purposes. Australia has some of the best practises to follow.
- Renwick and Havelock have decided to spend more on an advanced metre which includes electronics enabling more efficient reading of water usage. 916 metres have been installed in Renwick.

Bylaws changes and process - Clr Faulls, Dean Heiford

- Clr Faulls acknowledged that a lot of members had made submissions to the bylaw changes.
- Submissions for the Freedom Campers Bylaw changes closes today. There will be Hearings in the week
 of 14 September 2020 with Clr Oddie chairing. The proposed changes go to Assets and Services and
 then to full Council.
- Speed Limit By-Law changes are on the MDC website. You can make a submission on the MDC website at the following address: https://www.marlborough.govt.nz/your-council/have-your-say-consultations.
- The speed limit bylaw changes are being done by zones. Another series will be coming out after this initial bylaw process.
- There is a Dog Control Bylaw change also coming up. This has yet to go to Council on 17 September and copies of the bylaw will be available from 18 September at the Picton and Blenheim Libraries, Animal Control office (56 Main Street, Blenheim) and the Marlborough District Council office in Seymour Street.

A donation for use of the Picton Emergency Centre for meetings during 2020 CIr Faulls

• **CIr Faulls moved** that a donation be made to the Picton Emergency Operations Centre for use of their facility for PRF meetings this year. **Graham Low seconded, carried.**

Community Grants - CIr Faulls

- Clr Faulls advised that Community Grants are open for application until October.
- Working for Nature Grants open in October. Up to \$70 K can be accessed. There are two sections:
 - Habitat Marlborough to restore native habitat and improve biodiversity and fresh water supply -\$500 to \$5,000.
 - Protecting Marlborough animal control and plant pests \$500 to \$15,000.
- Tim mentioned there is a culling of feral goats on the 20 September. The Deerstalkers Association are involved. The goats this side of the Sounds, Whatamango back into Maraetai are out of control.

Marlborough Community Vehicle Trust - Bryan Strong

- The Trust was minimally affected by Covid, carrying 96 passengers between March and June, mostly from Picton to Wairau Hospital.
- Since starting in October 2016, they have transported 720 plus passengers.

Kickstart for Business - Graham Gosling

 On 16 September there will be a Kickstart for New Business for anyone interested. This will be about setting up or considering setting up a new business. Contact Business Trust Marlborough if you are interested in attending.

Fixing of road - Raewyn Buchanan

• Raewyn raised fixing of her road with Steve Murrin at a previous meeting but nothing has happened. Clr Faulls confirmed she would follow up Raewyn's concerns.

- Dean gave an update on three projects:
 - Wellness Centre and Pool
 - Heritage Centre
 - Mountain Bike Park
- Three consultants have put forward proposals. It is hoped that the projects will commence before Christmas.

 John advised of a very successful 'Make It Picton' day last Saturday. Clr Faulls commented that she had received some very good feedback about the day.

Covid 19 - Clr Faulls and Dean Heiford

- Both CIr Faulls and Dean talked about Marlborough currently being in a better position than some regions. A lot of businesses are changing the way they operate in order to come through this difficult time.

- Summer might be more challenging during Christmas and New Year with no cruise ships coming into Port.

DWSNZ Priority One

- · Bacteria Show compliance with a combination of
 - E-coli testing
 - Chlorine in the reticulation
 - Chlorine in the water leaving the treatment plant
- Protozoa Show compliance by:
 - Approved treatment process
 - Minutely water quality readings > 43,000/month
- · Drinking water assessor is provide the data

Other Testing

- Monthly groundwater tests nitrate, conductivity and chloride
- Pesticides, inorganic determinands are tested to DWSNZ requirements




Current Supply v Demand

- Peak day demand last summer 5,790 m³/d
- Similar peak demand over past 20 years
- Average day demand 3,690 m³/d
- Average day demand residential 3,225 m³/d
- 178 commercial meters
- Last year commercial 173,484 m³
- Last year total supplied 1,350,551 m³
- Commercial 13%


System Demand vs Capacity 2001 - 2008




Potential New Sources Investigated



Rainwater, Greywater and Wastewater



Reuse Alternative sources for garden water



- Rainwater storage \$2,900 for 5,000 litre
- Greywater laundry reuse \$4,100
- Saves some water (650 and 480 m³/day respectively) but not enough to solve long term needs
- · Can't be fitted on all properties
- Rainwater storage ineffective in big droughts



Reclaimed Water

- A reliable source is available in Picton
 - Reclaimed water from the Picton STP
 - Separate pipeline already in place from the STP to Waikawa
 - With high level of treatment reclaimed water can be used for all non potable uses

Demand Management Experience

- Water metering has just been introduced in Havelock and Renwick
- Renwick meters have been read (19 minutes)
- Meters immediately detected 192 leaks in Renwick out of 916 house connections

Renwick Domestic Meter Results

- Overall Domestic
 - Average 1.07 m³/d
 - Highest 71.08 m³/d
- · Properties with leaks
 - Highest use 71 m³/d
 - Average 3.27 m³/d
- Properties without leaks
 - Highest use 2.5 m³/d
 - Average use 0.48 m³/d

Port Update - Rose Prendeville 11 November 2020

- The project team is working through final pieces of preliminary design, and consultation with directly affected parties and stakeholders, ahead of lodgement of consent (on track for later in the year).
- Consenting processes will go through the COVID-19 Fast Track Consenting process (the project was named in the Bill).
- Waka Kotahi NZTA are continuing to work through their assessment of wider traffic effects, and are expected to have that fairly well progressed by the time consent applications are lodged.
