- The Council has delegated the authority to hear and consider submissions on the Marlborough Regional Pest Management Plan - Amendment Proposal to a Hearing Panel. Based on the evidence provided, the Panel will make a recommendation to Full Council. Full Council will make the final decision on the proposal.
- 2. The Panel comprises the following people:

- 5. A report in response to the submissions received will be prepared prior to the hearing. Marlborough District Council's Biosecurity Manager, Jono Underwood, has been tasked with completing this report. A copy of the report will be provided to all submitters and will be circulated no later than Monday 3 February 2020.
- 6. For submitters who indicated a wish to be heard, you may wish to give evidence by providing a written statement or discussing additional information, including expert evidence, which was not provided with your original submission, but which is relevant to and supports issues raised in that submission. If this is the case, written material should be provided to the Council one week ahead of the hearing. This date will be stipulated in the hearing notice.
- 7. Time for oral presentations and questioning is limited to 20 minutes per submitter, including any expert evidence. If you do not wish to appear, or do not require the full 20 minutes, you are requested to advise that in writing. Additionally, if you require more than one time allocation, that request also must be made in writing.
