Donations to a candidate of labour only or donations of goods and services that have a fair market value of \$300 or less do not have to be declared—see \$1030 of the LEA 2001. Candidates must declare donations from each contributor that exceed \$1500 in value. Where a contributor has made donations in instalment that sum to more than \$1500 in value, each contributing donation needs to be listed in Section A2 and the aggregated sum shown.
