# Notice of appeal to Environment Court against decision on proposed policy statement or plan

Clause 14(1) of Schedule 1, Resource Management Act 1991

To the Registrar Environment Court Christchurch

- Te Rūnanga a Rangitāne o Wairau appeals against decisions/parts of decisions of the MEP Hearing Panel, acting under delegated authority from the Marlborough District Council, on the Proposed Marlborough Environment Plan.
- 2. Te Rūnanga a Rangitāne o Wairau made a submission on the Proposed Marlborough Environment Plan.
- 3. Te Rūnanga a Rangitāne o Wairau is not a trade competitor for the purposes of section 308D of the Resource Management Act 1991.
- 4. Te Rūnanga a Rangitāne o Wairau received notice of the decision on 3rd March 2020.
- 5. The decisions were made by the MEP Hearing Panel, acting under delegated authority from the Marlborough District Council.
- 6. Te Rūnanga a Rangitāne o Wairau is a submitter in relation to the decisions/parts of the decisions appealed, or has referred to the provision in a submission or further submission.
- 7. The decisions/parts of the decisions that the Te Rūnanga a Rangitāne o Wairau is appealing are set out in Table 1 attached to this appeal notice.
- 8. As well as the specific reason given for each item in Table 1, the following general reasons are given for the appeals:
  - The decisions/parts of the decisions appealed are contrary to or inconsistent with the provisions of the Resource Management Act, particularly;
    - Section 6(a) the preservation of the natural character of the coastal environment (including the coastal marine area), wetlands, lakes and rivers and their margins, and the protection of them from inappropriate subdivision, use, and development.

- Section 6(e) the relationship of Maori and the culture and traditions with their ancestral lands, water, sites, waahi tapu, and other taonga.
- Section 6(f) the protection of historic heritage from inappropriate subdivision, use, and development.
- Section 7(a)kaitiakitanga.
- Section 7(f) the maintenance and enhancement of the quality of the environment.
- Section 8 Te Tiriti o Waitangi
- The decisions appealed relate to matters in the regional and district plan components of the Marlborough Environment Plan, which are inconsistent and do not give effect to the provisions of the regional policy statement component, specifically Objectives 3.1,3.2, 3.3 and 3.4 of Volume One of the Marlborough Environment Plan and how they relate to the protective measures for heritage and waahi tapu sites of significance as outlined in Policies 10.1.5, 10.1.6, 10.1.7, 10.1.8, and 10.1.9 in Volume One of the Marlborough Environment Plan. Further, these policies are restricted to items identified in Appendix 13 and have no relevance to other heritage resources or waahi tapu sites which may not yet have been identified, recorded or registered and have therefore not been included in Appendix 13. Finally, part of the site of great cultural significance at the Wairau Bar has been omitted from listing in Appendix 13.
- 9. The relief sought by the Te Rūnanga a Rangitāne o Wairau is set out alongside each item in Table 1. In addition, it is noted that alternative wording or relief may be acceptable in relation to any item, along with any necessary consequential relief.

Recent archaeological investigations of the sites within Area C classify the archaeological values of the features are potentially very high, there are likely to be in situ stratified deposits below the level of any previous disturbance.

The area is of extreme cultural, spiritual and historic significance to the Rangitane o Wairau people who have kaitiakitanga over this area, and therefore the area should be given the same weight and merit in terms of historical significance as the areas to the South of the Wairau Bar.
