1. Heritage New Zealand Pouhere Taonga wishes to be a party to the following proceedings:
Between Te Rūnanga o Kaikōura and Te Rūnanga o Ngāi Tahu v Marlborough District Council ENV- 2020-CHC-000046 on the proposed Marlborough Environment Plan ['Environment Plan']
2. Heritage New Zealand Pouhere Taonga made a submission dated 7 May 2020 on the Environment Plan.
3. Heritage New Zealand Pouhere Taonga is not a trade competitor for the purposes of section 308C of the Resource Management Act 1991.
4. Heritage New Zealand is interested in the following part of the proceedings :
 - Policies in Chapter 10
 - Methods in Chapter 10
5. (i). Heritage New Zealand Pouhere Taonga supports, or supports in part, the relief sought by Te Rūnanga o Kaikōura and Te Rūnanga o Ngāi Tahu in respect of the insertion of new policies 10.1.X and 10.1.XX and of method 10.M.X as the relief:
 - Is required to implement RMA s6f or s6e or RPS Objective 10.1.
 - The policies and methods relating to heritage are inadequate as they are restricted to items identified in Appendix 13 and have no application to other heritage resources or wahi tapu not included in Appendix 13.(ii) Heritage New Zealand Pouhere Taonga opposes the relief sought by Te Rūnanga o Kaikōura and Te Rūnanga o Ngāi Tahu
 - in respect to deletion of Policy 10.1.10, as the relief would not recognise the regulatory role of Heritage New Zealand Pouhere Taonga
 - in respect of Method 10.M.5 the deletion of the words "~~where an archaeological authority has not been obtained~~" would create an overlap and a confusion with the regulatory provisions of Heritage New Zealand Pouhere Taonga Act 2014 in respect to the archaeological resource.
6. Heritage New Zealand Pouhere Taonga agrees to participate in mediation or other alternative dispute resolution of the proceedings.
