

MEC is interested in the following particular issues

- Fresh water quality/ Te Mana o te Wai and the effects of livestock access to rivers, wetlands and lakes.
- issues relating to the discharge of agricultural waste and contaminants to land and water.

MEC opposes the relief sought because it will fail to achieve the related objectives and policies in the proposed Marlborough Environment Plan and the sustainable management of fresh water and soil in the Marlborough region.
