

Notice of person's wish to be party to proceedings

I, Dallas Campbell Hemphill, wish to be a party to the following proceedings: ENV-2020-CHC-67, an appeal by Environmental Defence Society Incorporated, against parts of the Marlborough District Council's decision on the proposed Marlborough Environment Plan.

I am a person who has an interest in the proceedings that is greater than the interest that the general public has; and a person who made a submission about the subject matter of the proceedings.

I am not a trade competitor for the purposes of [section 308C](#) or [308CA](#) of the Resource Management Act 1991.

I am interested in part of the proceedings relating to

- Chapter 8 of Volume 1;
- Chapter 2 of Volume 2;
- Chapter 3 of Volume 2; and
- Chapter 25 of Volume 2.


I am interested in the following issues:

- (a) Chapter 8 of Volume 1. - issues relating to indigenous biodiversity relating to forestry including issue 8A, objective 8.1 and policies 8.1.3, 8.2.2, 8.2.9, 8.M.3, 8.3.5, 8.3.7 and the proposed new policies.
- (b) Chapter 2 of Volume 2 - issues relating to vegetation clearance.
- (c) Chapter 2 of Volume 2 - rule 4.4.3 proposed forestry setback.
- (d) Chapter 25 of Volume 2 definition of "vegetation clearance".

I oppose the relief sought because:

- The relief sought is inconsistent with resource management principles;
- The relief fails to meet a s32 analysis;
- Some of the submissions and relief sought are out of scope; and
- The relief sought is inconsistent with credible science.

I agree to participate in mediation or other alternative dispute resolution of the proceedings.

Note to person wishing to be a party

You must lodge the original and 1 copy of this notice with the Environment Court within 15 working days after—

- the period for lodging a notice of appeal ends, if the proceedings are an appeal; or
- the decision to hold an inquiry, if the proceedings are an inquiry; or
- the proceedings are commenced, in any other case.

Your right to be a party to the proceedings in the court may be limited by the trade competition provisions in [section 274\(1\)](#) and [Part 11A](#) of the Resource Management Act 1991.

The notice must be signed by you or on your behalf.

You must serve a copy of this notice on the relevant local authority and the person who commenced the proceedings within the same 15 working day period and serve copies of this notice on all other parties within 5 working days after that period ends.

However, you may apply to the Environment Court under [section 281](#) of the Resource Management Act 1991 for a waiver of the above timing or service requirements (*see* [form 38](#)).
