- Friends of Nelson Haven and Tasman Bay Inc. (Friends) gives notice of intention to become a party to the appeal by the Marine Farming Association Incorporated and Aquaculture New Zealand (ENV 2020 CHC 074) on the proposed Marlborough Environment Plan (MEP).
- 2. Friends is an incorporated society in existence since 1973 whose objects are directed at protection of the coastal environment of Te Tau Ihu. Friends also made submissions on the proposed MEP and has lodged a separate appeal against decisions made on the proposed MEP (ENV 2020 CHC 033). Friends has an interest in the proceedings that is greater than the public generally.
- 3. Friends is not a trade competitor for the purposes of section 308C or 308CA of the Resource Management Act 1991.
- 4. Friends is interested in part of the appeal.
- 5. In particular, Friends is interested in all of the issues in relation to natural character and landscape, and indigenous biodiversity summarised at paragraphs 13 and 15 of the notice of appeal. Friends will seek resolution of the appeal in a manner that is consistent with the relief sought at Appendix 1 of the appeal by Friends on natural character and landscape provisions, and at Appendix 2 on protecting indigenous biodiversity, for the reasons given in Appendix 1 and 2 of the Friends' appeal. It will support the appeal to the extent that the relief sought is consistent with the relief sought is inconsistent with the relief sought in the Friends' appeal.
- 6. Friends agrees to participate in mediation or other alternative dispute resolution of the appeal, provided all parties to both this appeal and the Friends' appeal agree.
